

DECLARATION OF THE ESTABLISHMENT OF A FREE CHURCH

1 PURPOSE

The purpose of this document is to establish a free church for the purpose of worshipping, serving, loving, and glorifying Jesus Christ as our Lawgiver, Judge, and King, pursuant to the following.

*"For God is the King of all the earth; Sing praises with understanding."
[Psalms 47:7, Bible, NKJV]*

*"For the LORD is our Judge, the LORD is our Lawgiver, the LORD is our King; He will save [and protect] us."
[Isaiah 33:22, Bible, NKJV]*

We hold these truths self-evident, that we may establish said church an record the documents which establish it within any place where its buildings and officers may be found and yet not seek any form of government enumeration, registration, or recognition. We also hold it self-evident that any efforts to seek registration, enumeration, or recognition from the government of said entity within the jurisdiction of any government law shall render said Church no longer a Church whose sole head is Jesus Christ, but instead a church that is serving TWO masters in violation of the Bible upon which is it founded:

*"You shall have no other gods [including governments or earthly laws] before me [or my commandments]."
[Exodus 20:3, Bible, NKJV]*

*"Do not walk in the statutes of your fathers, nor observe their judgments, nor defile yourselves with their idols. I am the LORD your God: Walk in My statutes, keep My judgments, and do them; hallow My Sabbaths, and they will be a sign between Me and you, that you may know that I am the LORD your God."
[Ezekial 20:10-20, Bible, NKJV]*

The association and church established by the sovereign authority of God's Holy laws found in the Holy Bible, which is a covenant, a contract, and a trust indenture that makes all those believers who are party to into stewards, trustees, and fiduciaries of the Heavenly Father.

*"And we have known and believed the love that God has for us. God is love, and he who abides in love [obedience to God's Laws] abides in [and is a FIDUCIARY of] God, and God in him."
[1 John 4:16, Bible, NKJV]*

*"Now by this we know that we know Him [God], if we keep His commandments. He who says, "I know Him," and does not keep His commandments, is a liar, and the truth is not in him. But whoever keeps His word, truly the love of God is perfected in him. By this we know that we are in Him [His fiduciaries]. He who says he abides in Him [as a fiduciary] ought himself also to walk just as He [Jesus] walked."

*"It is not for you to know times or seasons which the Father has put in His own authority. But you shall receive power when the Holy Spirit has come upon you; and you shall be witnesses [fiduciary] to Me in Jerusalem, and in all Judea and Samaria, and to the end of the earth."

2 CHURCH NAME

This church congregation's name is _____(church name), A Free Church, Predestined by God and established in Heaven to minister on Earth; hereafter referred to as _____(church name).

1 **3 DEFINITIONS**

2 **Church and Congregation:**

3 The word "Church" in this document and other Governing Documents is defined as it is used in the Bible and also as
4 defined at law, below, to designate the body of Christ, which is the diverse body of all believers doing the work of Christ
5 throughout the world.

6 *'Who now rejoice in my sufferings for you, and fill up that which is behind of the affections of Christ in my flesh
7 for His body's sake, which is the Church.'*
8 *[Col 1:24, Bible, NKJV]*

9 *'For no man ever yet hated his own flesh; but nourisheth and cherisheth it, eve as the Lord of the Church: For
10 we are members of His body, of His flesh, and of His bones.'*
11 *[Eph 5:29-30, Bible, NKJV]*

12 *'For as we are many members in one body, and all members have not the same office; So we, being many, are
13 one body of Christ, and every one members one another. Having then gifts differing according to the grace that
14 is given to us, whether prophecy, let us prophesy according to the portion of the faith.'*
15 *[Rom 12:4-6, Bible, NKJV]*

16 **Church:**

17 *In its most general sense, the religious society founded and established by Jesus Christ, to receive, preserve,
18 and propagate His doctrines and ordinances*
19 *[Black's Law Dictionary, Sixth Edition]*

20 **Congregation:**

21 The word 'congregation' as used in this document is used synonymously to designate an assembly of two or more believers
22 who follow the teachings of Jesus Christ. _____(church name) Church is a local congregation of the One
23 True Church, of many congregations; headed by Jesus Christ. (Matt 18:20)

24 *19Again I say unto you, That if two of you shall agree on earth as touching any thing that they shall ask, it
25 shall be done for them of my Father which is in heaven.*

26 *20For where two or three are gathered together in my name, there am I in the midst of them.*
27 *[Matthew 18:19-21, Bible, NKJV]*

28 **4 LEGAL STATUS OF CHURCH FORMED**

29 **4.1 Church is an 'Establishment of Religion' in terms of the Constitution of the United States of America.**

30 _____(church name) and all of the members individually shall have the legal status described below:

31 1. We are fiduciaries of God, who is a "[nontaxpayer](#)", and therefore we are "nontaxpayers". Our legal status takes on the
32 character of the sovereign who we represent. Therefore, we become "[foreign diplomats](#)".

33 *"For God is the King of all the earth; Sing praises with understanding."*
34 *[Psalms 47:7, Bible, NKJV]*

35 *"For the LORD is our Judge, the LORD is our Lawgiver, the LORD is our King; He will save [and protect] us."*
36 *[Isaiah 33:22, Bible, NKJV]*

37 2. The laws which apply to all civil litigation relating to us are from the domicile of the Heavenly sovereign we represent,
38 which are the Holy Bible pursuant to:

39 2.1. God's Laws found in the memorandum of law below:

1 3. Our "domicile" is the Kingdom of God on Earth, and not within the jurisdiction of any man-made government. We can
2 have a domicile on earth and yet not be in the jurisdiction of any government because the Bible says that God, and not
3 man, owns the WHOLE earth and all of Creation. We are therefore "transient foreigners" and "stateless persons" in
4 respect to every man-made government on earth. See the following for details:

5 4. We are "Nonresident aliens" and "nationals" but not "citizens" under federal law. The reason this must be so is that a
6 "citizens of the United States" (who are all born in and resident within exclusive federal jurisdiction under 8 U.S.C.
7 §1401) may not be classified as an instrumentality of a foreign state under 28 U.S.C. §1332(c) and (d) and 28 U.S.C.
8 §1603(b).
9 5. We are not and cannot be "residents" of any earthly jurisdiction without having a conflict of interest and violating the
10 first four Commandments of the Ten Commandments found in Exodus 20. Heaven is our exclusive legal "domicile",
11 and our "permanent place of abode", and the source of ALL of our permanent protection and security. We cannot and
12 should not rely upon man's vain earthly laws as an idolatrous substitute for Gods sovereign laws found in the Bible.
13 Instead, only God's laws and the Common law, which is derived from God's law, are suitable protection for our God-
14 given rights.

15 *"For I was ashamed to request of the king an escort of soldiers and horsemen to help us against the enemy on*
16 *the road, because we had spoken to the king, saying 'The hand of our God is upon all those for good who seek*
17 *Him, but His power and His wrath are against all those who forsake Him.' So we fasted and entreated our God*
18 *for this, and He answered our prayer."*
19 [Ezra 8:21-22, Bible, NKJV]

20 6. We are "Foreign Ambassadors" and "Ministers of a Foreign State" called Heaven. The U.S. Supreme Court said in
21 U.S. v. Wong Kim Ark below that "ministers of a foreign state" may not be statutory "citizens of the United States".

22 *"For our citizenship is in heaven [and not earth], from which we also eagerly wait for the Savior, the Lord*
23 *Jesus Christ"*
24 [Philippians 3:20, Bible, NKJV]

25 *"I am a stranger in the earth; Do not hide Your commandments [laws] from me."*
26 [Psalms 119:19, Bible, NKJV]

27 *"I have become a stranger to my brothers, and an alien to my mother's children; because zeal for Your*
28 *[God's] house has eaten me up, and the reproaches of those who reproach You have fallen on me."*
29 [Psalms 69:8-9, Bible, NKJV]

30 *"And Mr. Justice Miller, delivering the opinion of the court [legislating from the bench, in this case], in*
31 *analyzing the first clause [of the Fourteenth Amendment], observed that "the phrase 'subject to the*
32 *jurisdiction thereof' was intended to exclude from its operation children of ministers, consuls, and citizens or*
33 *subjects of foreign states, born within the United States."*
34 [U.S. v. Wong Kim Ark, 169 U.S. 649, 18 S.Ct. 456; 42 L.Ed. 890 (1898)]

35 7. Our dwelling is a "Foreign Embassy". Notice we didn't say "residence", because only "residents" can have a
36 "residence". See the following for more details on this SCAM.

37 8. We are protected from federal government persecution by 18 U.S.C. §112 and the Foreign Sovereign Immunities Act
38 of 1976.
39 9. We are a "stateless person" within the meaning of 28 U.S.C. §1332(a) immune from the jurisdiction of the federal
40 courts, which are all Article IV, legislative, territorial courts. We are "stateless" because we do not maintain a domicile
41 within the "state" defined in 28 U.S.C. §1332(d), which is a federal territory and excludes states of the Union.
42 10. We are not allowed under God's law to conduct "commerce" or "intercourse" with the government by sending to it our
43 money or receiving benefits we did not earn. Black's Law Dictionary defines "commerce" as "intercourse". The Bible
44 defines "the Beast" as the "kings of the earth"/political rulers in Rev. 19:19:

45 *"And I saw the beast, the kings [heathen political rulers and the unbelieving democratic majorities who control*
46 *them] of the earth [controlled by Satan], and their armies, gathered together to make war against Him [God]*
47 *who sat on the horse and against His army."*
48 [Revelation 19:19, Bible, NKJV]

1 This is consistent with the Foreign Sovereign Immunities Act found in [28 U.S.C. §1605\(a\)\(2\)](#) , which says that those
2 who conduct "[commerce](#)" with the "[United States](#)" federal corporation within its legislative jurisdiction thereby
3 surrender their sovereignty. See:

5 Our Lord agreed with the above conclusions when he said:

6 *"Adulterers and adulteresses! Do you now know that friendship [and "citizenship"] with the world [or the*
7 *governments of the world] is enmity with God? Whoever therefore wants to be a friend ["citizen" or*
8 *"taxpayer" or "resident" or "inhabitant"] of the world makes himself an enemy of God."*
9 *[James 4:4, Bible, NKJV]*

10 Go to the link below to listen to a message from Pastor Mike Macintosh of [Horizon Christian Fellowship](#) given on
11 5/14/2006 confirming the above. In this message, he mentions that Christians are "aliens" when in fact, what we believe he
12 really means is "foreigners". We also note that a "national" but not "citizen" is a "foreigner" and a "foreign person" in
13 respect to every subject matter of federal legislation.

15 Any other status imputed or assumed by the government other than "foreign" and "sovereign" and "alien" amounts to
16 "compelled association" in violation of the [First Amendment](#) (see section 6 later for explanation). We must surrender our
17 sovereignty to Him and become His [fiduciaries](#) in order to be granted sovereignty over our government and our own affairs,
18 because ALL SOVEREIGNTY ultimately comes from Him:

19 *"Because you [Solomon, the wisest man who ever lived] have done this , and have not kept My covenant and*
20 *My statutes [violated God's laws], which I have commanded you, I will surely tear the kingdom [and all your*
21 *sovereignty] away from you and give it to your [public] servant."*
22 *[1 Kings 11:9-13, Bible, NKJV]*

23
24 *"Humble yourselves in the sight of the Lord, and He will lift you up [above your government]."*
25 *[James 4:10, Bible, NKJV]*

26
27 *"Those people who are not governed by GOD [and His law, both figuratively and literally] will be ruled by*
28 *tyrants."*
29 *[William Penn (after which Pennsylvania was named)]*

30
31 *"Let us hear the conclusion of this whole matter: **Fear [respect] God and keep His commandments [Laws***
32 ***found in the Bible], for this is man's all. For God will bring every work into judgment, including every secret***
33 ***thing, whether good or evil."***
34 *[Eccl. 12:13-14, Bible, NKJV]*

35 **4.2 Church is an 'Establishment of Religion' in terms of the Constitution of the United States of America.**

36 **Amendment I**

37 *Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or*
38 *abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to*
39 *petition the government for a redress of grievances.*
40 *[U.S. Constitution, Amendment 1]*

41 **4.3 Church is a FREE CHURCH**

42 A free church is a Christian church that is intrinsically separated from any government (as opposed to a theocracy, or an
43 "established" or state church). A free church does not define government policy, nor have governments define church
44 policy or theology, nor seeks or receives government endorsement or funding for its general mission.

1 This is historically what the Christian church was before Emperor Constantine, and did not appear again until the Protestant
2 Reformation.

3 This Church shall not seek nor accept government registration under I.R.C. §501(c)(3).

4 This Church shall not seek nor accept government enumeration, including Taxpayer Identification Numbers (TINs),
5 Employer Identification Numbers (EINs).

6 Any real estate held by the Church shall be held in a trust using an un-enumerated, unregistered foreign trust.

7 **5 LORDSHIP OF JESUS CHRIST**

8 Jesus Christ is the Head of ALL aspects of the Church, having sole and Sovereign Authority over it:

9 *'... Christ is the head of the Church, His body, of which he is the Savior.'*
10 *[Eph 5:23, Bible, NKJV]*

11 *And He is the Head of the body, the Church; He is the beginning and the first born from among the dead, so*
12 *that in everything He might have supremacy.'*
13 *[Col 1:18, Bible, NKJV]*

14 *'So in Christ we who are many form one body, and each member belongs to all the others.'* (Rom. 12:5)
15 *'Which He [God] exerted in Christ when he raised him from the dead and seated Him at His right hand in the*
16 *heavenly realms, far above all rule and authority, power and dominion, and every title that can be given, not*
17 *only in the present age but also in the one to come. And God placed all things under His feet and appointed*
18 *Him to be head over everything for the Church.'*
19 *[Eph 1:20-22, Bible, NKJV]*

20 **6 NON SECTARIAN AND NON DENOMINATIONAL**

21 The _____(church name) name was chosen as a name of reference only - not to create a sect or
22 denomination in any way. _____(church name) is not affiliated with any religious party or denomination.
23 The church is private, not public, though all are invited to attend the congregation's meetings for their stated purposes. One
24 does not need to be part of the _____(church name) to attend the _____(church name). The
25 term 'Christian Church' is used to describe the teachings and practices of the _____(church name) are based
26 upon the Christian Faith and doctrines as found in the Bible. _____(church name) does not have any
27 organizational ties with other 'Christian Church' groups, but recognizes that, spiritually, all believers are part of the one
28 Church that belongs to Christ (Rom 16:16) and God (Acts 20:28; 1 Cor. 1:2; 10:3; 11:16; 15:9; 2 Cor. 1:1; Gal. 1:13; 1
29 Thes. 2:14; 2 Thes. 1:4; 1 Tim. 3:5). The Bible teaches that a church will not be judged by it's name, but by it's works
30 (Rev. 2-3).

31 **7 MEMBERS**

32 The signer(s) of this document is/are the initial covenant member(s) of the _____(church name). Member(s)
33 may be added or removed in accordance with the Governing Documents and their covenants. As Jesus Christ works
34 primarily through men and woman by His Spirit, human decision-making power for _____(church name) is
35 established in it's members agreement to work together as brethren; it is not the same as membership in the Church, the
36 body of Jesus Christ. Specifically, it is possible that a person could become a member of _____(church
37 name) yet without having the spiritual change of heart necessary to be a member of the body of Christ; and it is readily
38 acknowledged that many members of His Church in the _____(church name) may not necessarily become
39 members of the _____(church name).

40 **8 GOVERNING DOCUMENTS**

41 The primary Governing Document of _____(church name) is the Holy Bible. Additional Governing
42 Documents are required to cover issues not specifically answered in the Bible and to establish principles and methods
43 specific to _____(church name). These additional Governing Documents of _____(church
44 name) are maintained by the _____(church name) Scribe.

1 **9 SCOPE OF POWERS**

2 _____(church name) Church, deriving its power form the Almighty Creator God and acting through its
3 members in accordance with its Governing Documents, is authorized to conduct Church functions it determines to be
4 necessary. Such activities may include, but are not limited to: Conducting Church Services and other worship activities;
5 establishing a witness to the local neighbors and all who come to visit; educating people in Bible basics; preparing them for
6 Federation in their marriage, family, church, community, government; helping and teaching the brethren to be fruitful
7 individuals in spite of personal difficulties and limitations; serving as a repository of Bible study literature and disseminate
8 it as God makes it possible; writing the experiences of the community in word, song or other media, to be an inspiration and
9 an encouragement to others for similar communities and local church congregations; opening financial accounts such as
10 bank accounts, brokerage accounts or other investment accounts; the purchase, lease or rental of congregational meeting
11 facilities and work facilities for ministries; the purchase, lease or rental of necessary equipment, musical instruments,
12 vehicles, supplies, implements or tools, and any and all other forms of property, both real and personal; the care,
13 remuneration and/or compensation of those laboring in church service; the distribution of tangible and intangible gifts or
14 benevolent charities; as well as any other necessary and appropriate financial transactions of _____(church
15 name), acting through it’s Governing Body, for the initiation, promotion, expansion and continuation of it’s activities.

16 **10 AUTHORIZATION**

17 The written organization and operation of _____(church name) is hereby petitioned for and authorized by
